### IV. HB 22-1137 DISCUSSION

Board has directed Manager to reach out to the Todd Creek Water District for potential contractor for tap install. Water is needed in the area before any other improvements may be done.

Mowing North Property - Board has approved to have two feet area next to the fence line on the north side of Todd Creek addressed by landscape contractor. Once the work is done, the Board will review if there are additional needs.

Ditches - Cat Tails/Wildflowers - Board discussed followed by a motion for any Design Review Request that comes in regarding any improvements to the ditches should go to the Board for review. The motion duly made by Anne Blakey and seconded by Steve Werth, motion passed by unanimous decision.

Homes without Complete Landscaping - Discussion

Prairie Dog Remediation - First baiting was done and the Board has authorized another baiting for removal of remainder of dogs.
